secretary and the Centre for Governance and Scrutiny it is proposed to look at skills in reviewing and understanding performance information. This will cover issues such as:-

- Availability of updated data for scrutiny members.
- How can scrutiny influence the way data is recorded and reported.
- o Should performance information only be reported on an exception basis.
- Benefits of having a lead scrutiny member for delving into the information.
- The type of performance information that should be a regular feature such as complaints, compliance with statutory timeframes for matters such as FoI request.

- 8 September 2023 Scoping and managing scrutiny reviews
- 1 December 2023 questioning skills
